

Our inclusive school ethos aims to give each student a broad curriculum which is responsive to individual needs and which will provide them with the knowledge, skills and attributes necessary for success in our rapidly changing world. This curriculum will be underpinned by British values.

PSHE and Citizenship Education – Citizenship and personal, social and health aspects of education form an important part of a student's life in school, and they are taught in Personal Development lessons, which take place once a fortnight, as well as through tutor time and assemblies.

Personal development is an important aspect of our curriculum provision, ensuring that students are able to make safe decisions, look after their physical and mental health and understand the local, national and international world around them.

Sex and Relationship Education is available for every student and meets the statutory requirements. According to age, students are given information and the opportunity to question and discuss. Due concern is given to the importance of family life and individual respect for others. This is delivered during Personal Development lessons, which take place once a fortnight, as well as through tutor time and assemblies.

Religious Studies – It is the Trustees' intention to ensure that the teaching of Religious Education accords with the agreed syllabus of the local S.A.C.R.E (Standing Advisory Committee on Religious Education). In order to meet this requirement Religious Studies is covered in Curriculum time in KS3 and through the Personal Development program in Years 10 and 11. The statutory content is also delivered in some school assemblies.

### Cox Green School's Curriculum

Students are taught a balanced timetable of core and foundation subjects during Key Stage 3 to give them the experience of a range of different subjects and to keep their skills as broad as possible. Students who arrive at the school with literacy skills that are significantly below the national standard are given additional literacy lessons to help them catch up. Citizenship, Sex and Relationship Education and Religious Education are spread throughout the key stage and delivered over a wide range of subjects; but are also delivered in Personal Development lessons, through the tutor time program, assemblies and through drop-down lessons.

At Key Stage 4 students choose their option subjects. The core subjects will be studied by all up to the age of 16.

At Key Stage 5 students choose the subjects they wish to study. PSHE is delivered to the year group through tutor time, and Personal Development lessons, which take place fortnightly and GCSE Maths and English is provided for those who have not passed it at Grade 4.

Appropriate attention is given to personal, learning and thinking skills to ensure our students develop as independent enquirers, creative thinkers, reflective learners, team workers, self-managers and effective participants.

Students are afforded the opportunity to develop their linguistic, mathematical, scientific, aesthetic, practical, enterprise, historical, digital, geographical, technological, physical and academic skills and talents through an extensive range of learning activities both within lesson time and as part of our extracurricular provision.

Cox Green keeps its curriculum flexible to best serve the needs of its student population. This may mean that the curriculum offer changes based on each cohort's strengths and preferences. Within a year group, students can be put on alternative timetables to help them succeed in areas of difficulty, or to stretch and challenge them in areas of interest.

The curriculum is worked out annually in response to achievements of year groups across the academic year, trends from career meetings and as a result of student voice. Ultimately, Cox Green endeavours to provide the most suitable curriculum for a year group or individual.

#### **In Summary**

This Curriculum Policy supports the values and visions of Cox Green School.

The Trustees are ambitious for our students and aim to provide them with a curriculum which will be stimulating, varied, relevant and appropriate.

Students have access to a range of appropriate qualifications enabling them to exploit their abilities and talents and to extend their education in a variety of ways so as to ensure their further progression in education, employment or training. Students will embark on accredited programmes of study at the point most appropriate to their ability and personal development.

A range of curriculum pathways are in place to enable students to personalise their curriculum to match their interests, needs and abilities. Our curriculum becomes increasingly responsive to student needs and more specialised as the students move through the school.

Attention to British values, SMSC (Spiritual, Moral, Social and Cultural) and equality underpins the development and delivery of our curriculum.

A range of mechanisms are in place to provide additional curriculum support to learners of all abilities. These include: SEND support, Read Write Inc., Numeracy Ninjas, Literacy intervention and Alternative Curriculum.

We work with a range of external partners in providing curricular opportunities, most notably the Maidenhead Sixth Form Consortium and Sports Academy.

We recognise that as well as the timetabled curriculum there are many avenues of learning, development and experience that can be promoted through extra-curricular activities, trips, visits, through participation in community activities and competitions which build cultural capital. We therefore encourage these activities.

Our curriculum is subject to ongoing review and is responsive to changing student needs, new statutory requirements and the opportunities provided by evolving qualification routes.
